In the complaint dated 25.01.2017 he has alleged that a meeting of General Body of Indian Floorball Federation was held by me in Rajiv Gandhi Bhawan, Safdarjung Airport, New Delhi on date 11.06.2012 by misusing my

position in Civil Aviation Ministry. He has also alleged that the meeting was held without the approval of the Civil Aviation Minister and I misused my position in the Civil Aviation Ministry by holding such meeting for my personal selfish gain, which amounts to serious crime and corruption. He has also enclosed the minutes of General Body's meeting dated 11.06.2012.

In this regard, it is submitted that on the date of meeting, i.e. 11.06.2012, I was not posted in the Ministry of Civil Aviation and I was working as the Director, Business and Country Relations in the International Crops Research Institute for the Semi-Arid Tropics (ICRISAT). I joined in the Ministry of Civil Aviation on 8th October, 2012 as Joint Secretary. Therefore, there is no question of misusing my position 11.06.2012 (copy of notification of Ministry of Civil Aviation is enclosed). The meeting which was held on date 11.06.2012 in Rajiv Gandhi Bhawan, must have been held by the Federation after seeking due concurrence of the competent authority. Besides this, it was a meeting of General Body of the Indian Floorball Federation, which works for promotion of Floorball throughout India and not a private function of any individual, Therefore the allegations are totally baseless and reflects the vulgar character of Sh. P.S. Gill. Moreover, he himself was present in the meeting as Treasurer of the Indian Floorball Federation and must be equally accountable. In light of above, the complaint is malafide and baseless.

In the complaint letter dated 28.04.2017 he has made the similar allegations as he had made earlier against me in his complaint dated 27.04.2016, which was sent to me by DoPT's letter no. 104/72/2016-AVD-I dated 31.08.2016. I have submitted a detailed reply on these allegations on 20.10.2016 (copy enclosed) and the matter has been closed by the Department of Personnel and Training vide letter no. 104/75/2016-AVD.I dated 07.02.2017 (copy enclosed). However, I may like to mention that as President of Indian Floorball Federation, I only worked for promotion of Floorball in India & not for my personal gain.

I would also like to submit that I have already resigned from the position of the President of Indian Floorball Federation and the President, Delhi Amateur Wushu Association w.e.f. dated 20.01.2017 and currently I am not holding any position in any sports association of federation.

In view of the above, it is requested to close the matter. I would also like to request to kindly penalize the complainant for making baseless, frivolous and false allegations again and again".
